



Review Your Lease Agreement

Settle your Balance & Plan Your Move

Review and settle any outstanding rent payments or other fees associated with your tenancy. Ensure all payments are up-to-date to avoid disputes and potential legal issues during the deposit refund process. Ensure you schedule utility shut-offs for after your move-out date.

Clean the Unit

Thoroughly clean the apartment, including appliances, windows, carpets, and fixtures. Check your lease for any specific cleaning clauses. Consider hiring professional cleaners if your lease demands professional standards for cleaning, or if you want to ensure a thorough job is done.

Repair Damages

Inspect the unit for any damage that occurred during your stay.
Replace or repair anything you've damaged, unless normal wear and tear. Patch holes in walls, repaint if necessary, and check the functioning of all fixtures and appliances.



Document the Unit's Condition

Take detailed photos or a video of the cleaned and repaired unit to document its condition. These records can be useful if there are any disputes with the landlord regarding the state of the unit at move-out.





Final Walk-Through, Handover Keys, Confirm Clear Balance

Schedule a final walk-through with Portsmouth Residential. This is a chance to go over the property together, discuss any issues, and hand over the keys. Ensure you receive a written statement of the property's condition upon your departure.

Ensure that you do not owe any balances with the Property Management Company.
